Joe Crescent, ASA, ARM

Jo Crescent is the first ARM applicant under the updated POV courses and accreditation pathway to be approved as an Accredited Senior Appraiser by ASA. We are proud of Jo and wanted to spotlight her recent accomplishment and learn more about her.



What drew you to the appraisal profession and your particular specialty?

I started working with Jack Young, my husband, in his appraisal business as an office manager. As I got more involved in the business, I got more interested in the appraisal process. However, after taking 3 POV classes, I realized that equipment appraisal was not going to work for me. When Bob Podwalny & Jack started focusing on Appraisal Review & Management, I realized that ARM was a great opportunity for me to earn an ASA.

What are the best circumstances that clients/prospects should come to you for help?

I intend to use the ARM designation to help appraisers develop their reports as fully and clearly as possible. That's a good use of my experience in the appraisal business, my organizational skills, and my writing/editing background. I've done a lot of appraisal subject editing with ASA and with individual appraisers. For instance, I worked with different aircraft appraisers on appraisal reviews for court cases. Last year I assisted an attorney with editing a legal brief. Currently, I do article editing for the M&E journal and the ARM journal. Of course, I'm also capable of doing straightforward appraisal review.

Please describe an interesting project you worked on recently.

I had a lot of fun working with MTS appraiser Franklin Reid on an article for the MTS journal about his management of a multifaceted appraisal of the Jamaican sugar industry. we reorganized and edited his lengthy and detailed submission into a compelling story of how a coalition of local appraisers won the assignment of the the largest public sector valuation exercise conducted in Jamaica, focusing on the complex process of appraisal collaboration. The article was originally printed in the MTS Journal and reprinted in the ARM journal.

What do you enjoy doing when you're not working?

I read a lot. Mostly fiction but also non-fiction books that address more wideranging topics — like Lawrence Busch's *Standards*, or the tome I've just gotten from the library *The Dawn of Everything: A New History of Humanity*. I also like to get outdoors: if not hiking or backpacking, at least walking through the neighborhood or drinking my coffee in the front yard.

What's your guilty pleasure?

Netflix series for sure. I try to be selective and limit my watching. I've recently finished "Call My Agent" and am trying to take a break before plunging back in!

Jo Crescent is part owner and operations manager of NorCal Valuation Inc. and has been an ASA member since 2011. She specializes in providing appraisal editing and review services to clients and ASA appraisers, mostly with the MTS discipline; she has worked within that discipline for over 10 years and completed 3 MTS POV classes.

Jo graduated from Grady College of Journalism and Mass Communication, University of Georgia, and went on to work in printing, layout, editing, and marketing content. She was developmental editor of the 4th edition of *Valuing Machinery and Equipment: The Fundamentals of Appraising Machinery and Technical Assets* and currently edits other ASA publications, including the ARM and MTS journals.
