Jack Young provides Attorneys, BV Appraisers, and CPAs with values they can depend on. He is a Fellow Accredited Senior Appraiser (FASA) of the American Society of Appraisers in Machinery and Equipment (MTS) and Appraisal Review & Management (ARM), a Chartered Member of Royal Institution of Chartered Surveyors (MRICS), and a Certified Public Accountant (CPA).

Jack worked for many years as an auctioneer and auction manager of business assets, machinery and equipment and was awarded Master Personal Property Appraiser (MPPA) designation from the National Auctioneers Association Education Institute. His experience in auditing, accounting, financial analysis, and auctioneering provides a strong base for the asset valuation concepts embraced by the Uniform Standards of Professional Appraisal Practice (USPAP) and the appraisal profession.

Recognized in 2021-2022 as ASA Appraiser of the Year, Jack was elected in 2023 to the International Board of Governors of the American Society of Appraisers. He has served the ASA internationally as Chair of the Appraisal Review & Management (ARM) subcommittee, on the Board of Examiners, as a member of the Ethics Board of Inquiry, and as past editor of the *Appraisal Review E-journal*, published quarterly by the American Society of Appraisers (ASA). He is an active member of the Northern California Chapter where he served as Chapter President and ARM Director.

Jack is a contributor to the current edition of *Valuing Machinery & Equipment: The Fundamentals of Appraising Machinery & Technical Assets*<sup>1</sup> and addressed the California Board of Equalization on the valuation of wine tanks as an invited participant in a panel discussion: *Assessment of Personal Property & Fixtures: Ensuring Accurate & Consistent Valuations & Application Methods*.

He received his B.S. Accountancy, Arizona State University, in 1988. While in college, he worked at the local mid-sized regional CPA firm Price, Kong & Company preparing monthly financial statements and performing tax work. Upon graduation Jack joined the audit department of international CPA firm KPMG in their Sacramento, California office. As a senior auditor, he worked primarily in the industries of banking, insurance, manufacturing, food processing and distribution. After KPMG, Jack was a financial analyst in the insurance and financial services industries.
